7) Your Company is committed to observe all the operative, administrative and commercial instructions given and relieve LIBERTY LINES from any responsibility in case of fine or reputational damages imputable to Your errors or omissions.

8) In the event of a departure impediment or interrupted travel, Your company is committed to refund the entire ticket fare (with the previous authorisation of LIBERTY LINES).

9) In case of suspensions of Telematics Services for any reason, temporary or definitive, imputable or not to LIBERTY LINES, Your Company has no right to claim anything. LIBERTY LINES can modify the functioning of the Telematics Services without notice, at anytime.
